Black Hole



LEICESTERSHIRE

This is a great way to overcome any fear of the dark. The black hole was constructed years ago by the campsites service team and has been enjoyed by many on the site ever since. You will find yourself crawling through a pitch-black maze, using touch to get around. If you're lucky and brave enough to venture further in, you may even find the second floor! Some great games can be made using this activity too, such as treasure hunts, time trials and even a version of cat and mouse.

Age: Any age

Group size: Recommended 15 per hour

Clothing: Recommend trousers due to the amount of crawling involved

Location: Further up from the main campfire circle, in the woods next to the Bouldering Wall.

Safety: Limit the number of participants inside the Black Hole to a maximum of 10 at any one time. The emergency exits must be unlocked before the activity starts and a leader positioned by the exits to help participants if required. Helmets to be worn, when inside the Black Hole. You must risk assess this activity yourself and document it, before using as it does depend on the capability of your young people to safely complete the course.

Instructors: This activity is self-run by the groups own leaders. It is recommended that you use at least two leaders to supervise the activity, but this will of course depend on the age of the participants.
